**VIOLATION NOTICE**

On October 23, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of JVIS FH, LLC located at 23944 Freeway Park Drive, Farmington Hills, Michigan. The purpose of this inspection was to determine JVIS FH, LLC's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) number 90-14D.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
EU-COATINGLINE	PTI No. 90-14D, EU-COATINGLINE SC I.2	Facility exceeded the Glycol Ether DB emission limit of 0.6 tpy calculated on a 12-month rolling time period from October 2020 – September 2024.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by December 23, 2024 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
