**VIOLATION NOTICE**

On August 24, 2016, the Department of Environmental Quality (DEQ) visited your Walat Farms A-4-25 and A-4-26 crude oil production facility located in Wisner Township, Michigan. The purpose of this inspection was to determine your facility's compliance with the requirements of the federal Clean Air Act and Part 55, Air Pollution Control, and Office of Oil Gas and Minerals (OOGM) Part 615, Supervisor of Wells, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451). The facility is also covered by air use permit 171-11A issued by the DEQ – Air Quality Division (AQD).

During the visit, the following violations were noted:

Walat Farms 4-25 and 5-25 crude oil production facility	OOGM R324.1120	Flow line markers were absent at the Walat 4.
	OOGM R324.1012	No well ID sign at the 5-25
	OOGM R324.1006	Spill at the drip tank in the line coming from the separator
	OOGM R324.1008	Spill not reported
	OOGM R324.701	No load out containment

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by November 28, 2016. The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.


