I talked with Dan the other day regarding the flagged violation of our body entry log and explained that we had added a column to our log to note if we had Pathological waste being cremated - based on EPA definition of visceral material (internal organs from autopsy etc.).

So the first image shows that we logged bodies under that assumption from the time of inspection in July 2021 until 02NO21. As the log indicates all entries (for all our log pages) were marker N = NO.

Dan thought it might be better to go with the Federal definition of Pathological waste meaning human bodies (or even animal bodies for our pet cremations). Therefore the second image is the revised log sheet we will now use, where all answers will be Y = YES (only human bodies and nothing else were entered for cremation.
