## VIOLATION NOTICE RESPONSE

Dear David,

This letter is in response to the violation that we received on March 28<sup>th</sup> 2023 and to show how Precise Finishing Systems is working towards being in compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) number 47-17; Condition VI 1 & 2. As well as Rule R336.1287(2)(c) record keeping for a paint booth.

The violations in question are listed below:

Both of these documents have been provided to the EGLE and will continue to submit usage sheets on a bi-monthly basis until it is established that we are keeping accurate/consistent records.

In regards to our violation of using more gallons than allowable under PTI 47-17, I have reached out the the permit section to increase our limit so we don't fall into violation again. If we are unable to obtain a new permit before the end of the fiscal year, then we will not exceed our 700 gallon limit, and will wait until January when our allowance resets.
