### **SRN P0156 PTI 182-10 Fisher Construction Aggregates Crusher inspection**

A relocation notice for a crusher and ancillary equipment permitted under PTI No. 182-10 was received by the Bay City AQD office on January 5, 2022. The relocation notice was for the crusher to operate January 14 through December 31, 2022 at a site in Williams Township. The Bay City AQD office also received an inquiry from a Williams Township resident that expressed concerns about having a crusher operation.

I (KLB) contacted FCA to verify the relocation notice information and learn more about the activity. The crusher was contracted to complete work at the Chip Road site owned by Gushow. The crusher had originally been relocated to the site in September 2021. A relocation notice had been submitted to the AQD to perform crushing operations through December 2021.

The crusher malfunctioned in the fall of 2021 and was taken off site to be repaired. Repairs were completed in December 2021 and the crusher equipment was returned to the Chip Road site. The crusher operated off and on through December 2021 and January 2022.

I provided the concerned resident with information about the FCA crusher and general crusher operating and permitting conditions. I also encouraged the citizen to contact me if dust or impacts from crusher operations arose.

On February 11, 2021 I spoke with Dean Gatehouse, Superintendent for Fisher Construction Aggregates (FCA). Material that needed to be processed was still present on the site in January 2022. FCA continued crushing operations into January 2022 and submitted a new relocation notice that would allow the crusher to operate at the Chip road site through 2022.

The Chip Road site has a pond and the crusher uses water from the pond for dust control. The crusher operated has been trained and certified to read visible emissions. The operation completed and passed VE testing in 2010. Conveyors that were added in 2014 have also been tested for VEs.

Per Mr. Gatehouse the Williams Township Supervisor visited the site in response to a citizens concern about noise and dust. At that time and while the crusher was operating Ddcibel readings taken on site showed acceptable levels and no dust issues were noted.

I requested site operating records for December 2021 and January 2022. The company provided them on Feb 16, 2020. The site operated one day and crushed 425 ton in December 2021. The crusher processed 17,000 ton and operated 15 days in January 2022 .

**On February 23, 2022 I drove to the Chip Road site and verified the crusher equipment had been removed.**
