FACILITY BACKGROUND

St. Mary's Cement, Inc. has a portable concrete crusher which is currently located on the site of St. Mary's Cement (B3567). The facility was issued a general portable crusher permit in September 10, 2020. This was an announced inspection.

REQUIRED PPE

During the onsite inspection, I wore steal toed shoes, eye protection, a hard hat, a safety vest and a N95 facial mask.

COMPLAINT/COMPLIANCE HISTORY

No complaints have been received regarding this crusher.

PROCESS EQUIPMENT AND CONTROLS

The facility has a portable concrete crusher which is currently located on site at St. Mary's Cement.

INSPECTION NARRATIVE

I arrived at the site to determine compliance with the portable concrete crusher. During the preinspection meeting, I discussed the permit conditions with Mr. Eric Olson and the plant

manager. I asked when the facility started using the crusher. I was told that the crusher was on site, but the facility had not yet used the crusher. They said that they planned to use the crusher in the near future. I reminded them that EGLE-AQD would need to be notified of a start-up date when they began using the crusher. Next, we walked to the roof of the mill building at St. Mary's Cement. From this location, I could see the crusher and verified that it was not being used.

APPLICABLE RULES/PERMIT CONDITIONS

The facility was issued general PTI 104-20 for the portable concrete crusher on September 10, 2020. The conditions were not evaluated at this time because the crusher has not yet been used by the facility. I reminded the facility of the start-up notification requirements when they begin operating the crusher.


MAERS REPORT REVIEW
