VIOLATION NOTICE

On March 27, 2017, the Michigan Department of Environmental Quality (MDEQ), Air Quality Division, performed an asbestos NESHAP (National Emission Standard for Hazardous Air Pollutants) complaint investigation at 353 West Main Street, Benton Harbor, Berrien County. The purpose of this investigation was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to my investigation, Blue Star 14, LLC owns the subject commercial facility and Henderson Brothers Tree Service performed the demolition activities at this facility. The demolition took place on or about the week of March 20, 2017. The National Emission Standard for Asbestos holds both the owner and the operator equally liable for the violations.

During the investigation, staff observed the following: The former commercial property was partially demolished and various piles of demolition debris and a roll-off waste container remain on site. The liable parties had failed to perform a thorough inspection and provide a 10-working day notice prior to any demolition activities.
