VIOLATION NOTICE

On March 15, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), performed an asbestos inspection at 8998 East M-21, Ovid, Clinton County, Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Mr. Rick Hansen of Hansen's Quik Stop, Inc. owns the property and performed the demolition activities at the site. The National Emission Standard for Asbestos holds the owner and operator equally liable for violations.

During the investigation, DEQ AQD staff, Mr. Jeremiah Brown observed the following:

The subject property had been demolished with no scheduled demolition notification submitted.
