Inspection Summary

I entered the visitor entrance area where Brad Case let me in. I informed Brad of the purpose of my visit and provided him a copy of the Inspection Brochure and my business card. Brad escorted me to the mechanical room area and stated he would get Karl Lang who is the GISD Assistant Director of Operations to assist me. The building is in the process of being completely renovated with completion plans in or around 2018. When Karl arrived, I provided him with my business card and informed him of my purpose.

Karl led me into the boiler room "Room 604" where we walked around and attempted to find the incinerator. We found what we believed was the incinerator built into the building structure. Although the incinerator is still installed, it was clearly not being operated; removal would take considerable reconstruction. I feel comfortable stating this device is still installed but is non-operational thus been removed and the permit is no longer valid. I informed Karl that I would void the permit associated with the incinerator. No other permits are issued to this site and I departed at approx. 10:30am.
