### VIOLATION NOTICE

On June 21, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD) performed an asbestos inspection at 1001 North Pine Street and 635 Brook Street, Lansing, Ingham County, Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to our investigation, Mr. Mark Bolle (owner) of Bolle Contracting LLC, was the operator who conducted the asbestos abatement and demolition activities, and the Ingham County Land Bank is the property owner of both addresses mentioned above. The National Emission Standard for Asbestos holds the owner and operator liable for all violations.

During the investigation staff observed/discovered the following:

The subject property at 1001 North Pine Street was demolished and the debris was removed from the site. Several pieces of asbestos cement board siding were found around the site. At 635 Brook Street, the subject property had the asbestos abated however, air duct thermal systems insulation (TSI) was located in multiple locations inside and pieces of asbestos cement board siding were found on the structure and also on the ground.

The written response should include: the date(s) the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations, and the date(s) by which these actions will take place; and what steps are being taken to prevent a recurrence. The signed written response from owner and operator to this violation notice may be submitted by mail and directed to my attention at; DEQ AQD, P.O. Box 30260, Lansing, Michigan 48909, or may be scanned and sent as an email attachment to brownj9@michigan.gov.

If you believe the above observations or statements are inaccurate or do not constitute a violation of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
