SECOND VIOLATION NOTICE

On May 17, 2022, the Michigan Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) received a complaint regarding the burning of waste material being conducted at Lake Breeze Party Store located at 3985 Saginaw Street, National City, Michigan. The AQD staff contacted Lake Breeze Party Store on May 18, 2022, to determine compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; Rule 336.1310 (R 310).

On May 24, 2022, the AQD sent the Company a Violation Notice citing a violation of R 310, confirmed through a phone conversation with Pat Brown. The AQD requested the Company's written response by June 14, 2022. A copy of this Violation Notice has been enclosed for your reference. As of the date of this letter, the AQD has not received the Company's written response to the cited violation.

Please be advised that failure to respond in writing and identifying actions the Company will take or has taken to resolve the cited violation may result in an escalated enforcement action by the AQD. Please provide the information requested in the Violation Notice dated May 24, 2022, by August 4, 2022, which corresponds to 14 days from the date of this letter.

The Company's written response must be submitted to Nathanael Gentle, EGLE, AQD, Bay City District Office, at 401 Ketchum Street Suite B, Bay City, Michigan 48708 and submit a copy to Jenine Camilleri, Enforcement Unit Supervisor at EGLE, AQD, P.O. Box 30260, Lansing, Michigan, 48909.
