VIOLATION NOTICE

On June 20, 2018, the Department of Environmental Quality (DEQ), Air Quality Division, was informed of multiple demolitions occurring in the city of Caspian, Iron County. After investigation it was determined that the demolitions which had been completed or currently in process were not in compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Iron County owns the facilities and MD Contracting, Inc. performed the demolition activities at the facility. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

During the investigation staff determined the following:

Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by July 11, 2018, (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Iron County or MD Contracting, Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide factual information to explain your position.
