VIOLATION NOTICE

On September 25, 2018, the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of a vacant home located at 321-323 West Mason Street, Jackson. The purpose of this investigation was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to our investigation, the City of Jackson owns the facility and Adrian Environmental, LLC performed the abatement activities. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff observed the following:

Abatement activity had been done on the subject facility. However, during my postabatement inspection, I observed regulated asbestos containing material (RACM) in the form of pipe insulation on the second floor, which contained 30% of chrysotile asbestos.

Please initiate actions necessary to correct the cited violations and submit a written response to this violation notice by November 1, 2018, (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations, and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
