SECOND VIOLATION NOTICE

On July 23, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) performed an asbestos inspection at 3717 Cork Street, Kalamazoo, Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On August 7, 2019, the AQD sent a Violation Notice (VN) citing a violation discovered because of the inspection and requested a written response by August 28, 2019. A copy of this VN has been enclosed for your reference. As of the date of this letter, the AQD has not received the written response to the cited violation.

Please be advised that failure to respond in writing and identifying actions taken to resolve the cited violation may result in an escalated enforcement action by the AQD. Please provide the information requested in the VN dated August 7, 2019 by September 12, 2019, which corresponds to 14 days from the date of this letter.

The written response must be submitted to Mr. Craig Dechy, EGLE, AQD, P.O. Box 30260, Lansing, Michigan 48909-7760 and must include a copy to Mr. Jason Wolf, Enforcement Unit, EGLE, AQD, at the same address. Or the response may be scanned and sent to dechyc@michigan.gov and wolfj2@michigan.gov.
