### **VIOLATION NOTICE**

Dear Mr. Rosendall and Mr. Riemersma:

On November 13, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), performed an asbestos NESHAP (National Emission Standard for Hazardous Air Pollutants) inspection at 4050 Plainfield Avenue NE, Grand Rapids, Kent County, Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to my investigation, Jupiter Partners, LLC owns the subject property and Gro America performed the demolition activities. The National Emission Standard for Asbestos holds both the *owner and operator* equally liable for any violations.

During the inspection, staff observed the following:

The subject commercial property was found to not have a notification of intent to renovate/demolish. The building structure was approximately 75 percent demolished and disposed of. In discussion with Mr. James Rosendall of Gro America, he stated he was not aware of the NESHAP program and requirements and that only a demolition permit was submitted to Plainfield Charter Township. An asbestos survey, abatement, and disposal were completed prior to demolition as indicated from the post remediation inspection report and the asbestos waste manifest.

Please initiate actions necessary to correct the cited violation and submit a written response to this violation notice by December 10, 2019, (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation, and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
