VIOLATION NOTICE

On November 15, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of former Almont Elementary School located at 401 Church St., Almont. The purpose of this inspection was to determine Novak Supply and Equipment, Inc's and Almont 401 LLC's compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, 401 Almont, LLC owns the facility and Novak's Supply and Equipment, Inc. performed partial demolition activities at the facility. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff observed that a portion of the former school had been demolished without the required 10-day notice of intent to demolish.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by December 13, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the



dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If 401 Almont, LLC and/or Novak's Supply and Equipment, Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
