VIOLATION NOTICE

On January 15, 2016, the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of a demolished facility located at 306 East Grand River Ave, Fowlerville, MI. The purpose of this inspection was to determine this sites compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Mr. Matt Soave owns the facility and Mr. Pat Shields performed the demolition activities at the facility. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff observed the following:


Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by March 4, 2016 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
