## VIOLATION NOTICE

On February 13, 2017, the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of the commercial buildings located at 5703, 5705, 5723 and 5741 E. Eight Mile, Warren. The purpose of this inspection was to determine Marogi Enterprises, LLC's and RJ Hoffman Management, Inc.'s compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Marogi Enterprises, LLC owns the facility and RJ Hoffman Management, Inc. performed the demolition activities at the facility. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff arrived to conduct an inspection at 5708 E. Eight Mile in Warren as was listed on the 10 day notification of intent to renovate/demolish that was submitted to the DEQ. It was discovered there was no such address; however RJ Hoffman Management, Inc. was observed conducting demolition activities at 5703, 5705, 5723 and 5741 E. Eight Mile, Warren.

The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If RJ Hoffman Management, Inc. and/or RJ Hoffman Management, Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to me during my inspection of 5703, 5705, 5723 and 5741 E. Eight Mile, Warren.
