## **VIOLATION NOTICE**

On November 13, 2018, the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of the former Wright and Filippis building located at 11570 E. Eleven Mile, Warren. The purpose of this inspection was to determine United Hospitality Group III, LLC's and Meram Construction, LLC's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, United Hospitality Group III, LLC owns the facility and Meram Construction, LLC performed the demolition activities at the facility. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, AQD staff noted the following violation:

The response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are

proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If United Hospitality Group III, LLC and /or Meram Construction, LLC believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide factual information to explain your position.
