VIOLATION NOTICE

On May 15, 2020, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of the commercial property located at 43653 Gratiot, Clinton Township. The purpose of this inspection was to determine Macomb County Land Management, LLC's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Macomb Land Management LLC owns the property and demolished the building. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

AQD staff noted that the building had been demolished without the submittal of a notice of intent to renovate/demolish to the AQD 10 days prior to demolition. A thorough inspection for asbestos had not been conducted prior to demolition.

Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by June 24, 2020 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violations are ongoing; a summary of the actions that have been taken and are

proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
