Dear J. Marcos Jiminez, Salem Jiddou, and Al Saylor:

VIOLATION NOTICE

On December 12, 2022, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of The Canton Inn located at 28541 Gratiot, Roseville, MI. The purpose of this inspection was to determine the building owner's and operator's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, J. Marcos Jiminez owns the facility and SJ Design & Construction LLC and Al Saylor performed the demolition activities at the facility. The NESHAP for Asbestos holds both the owner and operators equally liable for violations.

During the inspection, staff observed the following:

Driving by the site, staff noticed what appeared to be a bare area where a demolition may have taken place. During the investigation, it was discovered that a restaurant was located there and demolished sometime in September of 2022. Further investigation showed that a demolition permit from the City of Roseville was issued on September 16, J. 2022, and an open-hole inspection from the City of Roseville Building Department was conducted on October 3, 2022. Attempts were made to contact the Demolition contractors to request a Notification of Intent to Demolish and an asbestos survey, but they did not respond.

All parties please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by February 3, 2023 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
