VIOLATION NOTICE

On September 2, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of South Monroe Townsite Elementary School located at 15488 Eastwood, Monroe. The purpose of this inspection was to determine Monroe Public Schools and D&R Demolition Corporation's compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Monroe Public Schools owns the facility and D&R Demolition Corporation performed the demolition activities at the facility. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

AQD staff conducted an inspection at the site on September 2, 2016. Samples collected during the inspection identified window glaze. The window glaze was classified as a Category II material that would have been rendered friable during demolition practices.12" x 12" blue floor tile also tested positive for asbestos.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by November 17, 2016 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence. Please note that both parties are required to submit a response to this violation notice.

If Monroe Public Schools and /or D&S Demolition Corporation believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
