## VIOLATION NOTICE

On January 4, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) conducted an inspection of a commercial building located at 276 South Charles Street, White Cloud, Newaygo County, Michigan.

The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, David J. Robinson and Ryan Robinson is the owner and conducted demolition/cleanup activities at the site. The National Emission Standard for Asbestos (NESHAP) holds the owner and operator liable for all violations.

During the investigation staff observed the following:

The subject structure located at 276 South Charles Street was demolished in March 2023 at the order of the fire department to assist in extinguishing the fire. The burnt debris was still on-site and removed on or around December 27, 2023. There was no asbestos survey conducted prior to the fire or removal of the debris. Because of this, ALL debris must be treated as asbestos containing waste material. After looking at the Asbestos Notification System it was determined that a 10-working day notification was not submitted prior to removal of debris from the previous demolition activities. After further investigation, it was determined that other violations had occurred such as the debris was not kept wet, there was no contractor supervisor trained person on-site during the removal of the debris, and the debris was not manifested and disposed of as asbestos containing waste material in a Type 2 landfill.

Please initiate actions necessary to correct the cited violations and submit a written response to this violation notice by February 23, 2024 (which coincides with 22 calendar days from the date of this letter). The written response should include: the date(s) the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations, and the date(s) by which these actions will take place; and what steps are being taken to prevent a reoccurrence. The *signed* written response from the *owner and operator* to this violation notice, may be submitted by mail and directed to Jeremy Howe, TPU Supervisor at EGLE, AQD, P.O. Box 30260, Lansing, Michigan 48909-7760 and submit a copy to Jason Wolf, Enforcement Unit, at EGLE, AQD, P.O. Box 30260, Lansing, Michigan 48909-7760. If you believe the above observations or statements are inaccurate or do not constitute a violation of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
