Quigley Industries, Inc. --Plant-2 (U-63-10-0174) -- closed and consolidated into N6900 (see below) as a result of 2008 economic crisis.

N6900 and A3575: Quigley Industries, Inc. –Plant-1, 38880 Grand River Ave., Farmington Hills, Michigan 48335-1526, is operating at this site. However, for the same address, a duplicate SRN A3575 was issued to Hydralink Corporation. According to Ms. Carol C. Quigley, Quigley Industries moved into this building about 1996. Qugley's Plant-1 manufactures stamped parts for transportation automotive industry; especially heavy-duty trucks such as Volvo, Detroit Diesel, Navy Star, etc.

On January 04, 2019, I conducted level-2 self-initiated FY 2019 inspection of Quigley Industries, Inc. located at 23890 Industrial Park Dr., Farmington Hills, Michigan 48335; Quigley moved into this building in 1996. The inspection was conducted to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994, PA 451; Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) administrative rules.

Ms. Carol C. Quigley stated that she shutdown all operations at Plant No. 2 located at 23890 Industrial Park Drive, Farmington Hills, due to dire economic conditions (2009 Great Recession) and moved some operations to Plant 1 (N6900). Plant 1 operated, and is continuing to operate, without business interruption, since 1996. Currently (January 2019), Plant-2 building is empty and unoccupied.

Conclusion:

Qugley's Plant 2 operations are permanently shutdown and consolidated into Plant 1 (N6900). Plant-2 building is empty and unoccupied.
