On July 23, 2014, AQD staff, Erik Gurshaw, conducted a self-initiated, unannounced inspection at Reid Glass Company, Inc. located at 22223 Telegraph Road in Southfield, Michigan. The purpose of the inspection was to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control of Natural Resources and Environmental Protection Act, 1994 Public Act 451; and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) Rules.

Upon arriving at the facility, AQD staff introduced themselves and stated the purpose of the visit to Mr. John P. Cothery, co-owner. Mr. Cothery indicated that Reid Glass operates Monday through Friday from 8:30 AM until 5:00 PM and that 15 people are employed by the company. Mr. Cothery assisted AQD staff during the inspection.

Reid Glass fabricates glass mirrors, shower doors, countertops, and tables for residential customers. The company buys sheets of glass, cuts the glass to customer specifications, and installs the finished products at residential households. Equipment at the facility includes the following: 2 handheld sanders; 1 grinder; 1 beveler; 5 glass scorers; 1 glass washer which uses dishwasher soap; 2 small natural gas space heaters; and a 6,800 Watt Ridgid emergency generator. All of the glass working machines vent to the general plant environment and are, therefore, exempt from Permit To Install (PTI) requirements pursuant Rule 285(l)(v). The natural gas heaters are exempt from PTI requirements pursuant Rule 282(b)(i). The emergency generator is subject to NSPS Subpart ZZZZ for RICE engines, but the AQD has not accepted delegation for this subpart at area sources of hazardous air pollutant emissions (HAPs).

Based on the inspection, it was determined that Airodyne Industries, Inc. is in compliance with all applicable air rules and regulations.
