On June 8, 2015, AQD staff, Erik Gurshaw, conducted a self-initiated, unannounced inspection at Mobility Works located at 1604 E. 14 Mile Road in Madison Heights, Michigan. The purpose of the inspection was to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control of Natural Resources and Environmental Protection Act, 1994 Public Act 451; and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) Rules.

Upon arriving at the facility, AQD staff introduced themselves and stated the purpose of the visit to Mr. Mark Buday, General Manager. Mr. Cothery indicated that Mobility Works operates Monday through Friday from 8:00 AM until 5:00 PM and that 12 people are employed by the company. Mr. Buday assisted AQD staff during the inspection.

Mobility Works modifies and installs equipment to make vehicles handicap accessible. Most of the equipment which the company modifies and installs consists of ramps or lifts for wheelchairs. The ramps and lifts are premanufactured and are installed/modified for the VA, State, and local government fleet vehicles or for the vehicles of private citizens. The company has a drill press, a grinder, a portable grinder, and 2 car hoists. The drill press and grinder exhaust to the general plant environment and are exempt for Permit To Install (PTI) requirements pursuant to Rule 285(I)(vi) (B). The portable welder also exhausts to the general plant environment and is exempt from PTI requirements pursuant to Rule 285(i).

Based on the inspection, it was determined that Mobility Works is in compliance with all applicable air rules and regulations.
