VIOLATION NOTICE

On March 14 and April 20, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD) conducted an investigation of the demolition of the pedestrian bridge located at M59 between Telegraph and Woodward in Pontiac. The purpose of this investigation was to determine the City of Pontiac's and Dan's Excavating, Inc.'s compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, National Emission Standards for Hazardous Air Pollutants, Subpart M, and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, the City of Pontiac owned the bridge and Dan's Excavating, Inc. performed the demolition activities at the bridge. The National Emission Standard for Asbestos holds both the owner and operator liable for violations.

DEQ AQD staff observed that the pedestrian bridge had been demolished without the required notification to the DEQ AQD.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by May 29, 2018 (which coincides with 21 calendar days from the date of this letter). The written response should include:

- A copy of the letter ordering the bridge to be demolished;
- A copy of the asbestos survey for the bridge;
- A completed notification for the bridge's demolition,
- The dates the violation occurred;
- An explanation of the causes and duration of the violation, and whether the violation is ongoing;
- A summary of the actions that have been taken and are proposed to be taken to correct the violation; and
- The dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If the City of Pontiac and/or Dan's Excavating, Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to me during my inspection of the pedestrian bridge.
