VIOLATION NOTICE

On Thursday (July 12, 2018), the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of the former Gold Front building located at 417 North Main Street and 418 North Huron Street, Cheboygan, Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, the County of Cheboygan owns the facility and Pitsch Wrecking, Inc. performed the renovation and demolition activities at the facility. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff observed the following:

That the Pitsch Wrecking, Inc. demolition crew was unable to provide the roof sample results requested by AQD staff on Tuesday, June 26, 2018, when renovation was being undertaken in the facility by Pitsch Wrecking, Inc. The Asbestos & Paint Survey prepared by Mackinac Environmental Technology, Inc. (MET Project No. M17-2792) dated January 8, 2018, indicated that the roofing material samples had not been collected.

Please initiate actions necessary to correct the cited violation and submit a signed written response to this Violation Notice by August 6, 2018 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
