VIOLATION NOTICE

On September 19 and 20, 2018, the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of the former Salvation Army located at 108 and 118 W. Lawrence, Pontiac. The purpose of this inspection was to determine M1 Bunker LLC's and RTR Services Corp's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, GFL Environmental USA Inc is the waste contractor, M1 Bunker LLC owns the facility and RTR Services Corp. performed the renovation activities at the facility. The NESHAP for Asbestos holds both the owner and operators equally liable for violations.

During the inspection, DEQ staff Joseph Goeddeke observed Thermal System Insulation (TSI) in two GFL roll-off bins on September 19, 2018. Lab results for a sample collected at that time proved it was regulated asbestos containing material (RACM). On the morning of September 20, 2018, a GFL driver that was removing one of the bins was informed that there was suspected asbestos containing waste material (ACWM) in the dumpster. However, the driver drove off and deposited the ACWM at the Oakland Heights landfill as regular construction and demolition debris. Lab results for TSI collected from the dumpster tested positive for asbestos.

Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by October 23, 2018 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violations occurred; an explanation of the causes and duration of the violations, whether the violations are ongoing, a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place, and what steps are being taken to prevent a reoccurrence.

If GFL Environmental USA Inc., M1 Bunker LLC or R.T.R. Services Corp., believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide factual information to explain your position.
