SECOND VIOLATION NOTICE

On October 16, 2018, the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of the property located at 5164 Rochester Road, Troy. The purpose of this inspection was to determine BBI Holdings, LLC's and Boverhof Builders, Inc's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On October 24, 2018, the AQD sent BBI Holdings, LLC and Boverhof Builders, Inc. a Violation Notice citing a violation discovered as a result of the inspection and requested your written response to the violation notice by November 14, 2018. A copy of that letter is enclosed for your reference. Although a copy of the asbestos survey and abatement records were provided, BBI Holdings, LLC did not provide a written response to the violation notice as requested.

Please be advised that failure to respond in writing and identifying actions BBI Holdings, LLC will take or has taken to resolve the cited violation may result in escalated enforcement action by the AQD. Please provide the information requested in our October 24, 2018 letter by January 30, 2019, which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.
