VIOLATION NOTICE

On November 5, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division, conducted an inspection of the former Montessori located at 2101 S. Opdyke Rd, Bloomfield Township, MI. The purpose of this inspection was to determine The Adam's Group, Inc's and Bright Sun Investments, LLC's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Bright Sun Investments, LLC owns the facility and the Adams Group, Inc. performed the demolition activities at the facility. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

On November 5, 2019, EGLE AQD staff arrived on site to conduct an inspection prior to the notified start date of demolition (November 6, 2019). However, the building had been demolished several days prior to AQD staff's arrival.

the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
