VIOLATION NOTICE

On August 31, 2020 and September 9, 2020, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of the commercial property located at 15919 W. 10 Mile Road, Southfield. The purpose of the inspections was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Dhal Real Estate, LLC owns the property and Mayes Floor Covering performed the asbestos abatement activities at the property. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, AQD staff observed a commercial building demolition. There was an asbestos survey conducted prior to demolition. The contractor hired to perform asbestos abatement told the AQD that he did not abate all regulated asbestos containing materials prior to demolition of the structure, and that the building was demolished with (asbestos ceiling panels, drywall joint compound, floor tile and furnace cloth) still in the building. The company that performed abatement work had removed approximately 50 standard sized asbestos waste bags of friable ceiling panel debris from the building. There was no 10-day notification filed for this friable abatement and the company performing the work does not hold a valid Asbestos Abatement Contractor's license or a valid Asbestos Contractor/Supervisor accreditation in the State of Michigan.

	40 CFR 61.145(c)(4)	Failure to contain in leak tight container-the building was demolished without abatement of all RACM.
	40 CFR 61.145(c)(8)	Failure to have a site supervisor trained in the asbestos NESHAP regulations on the site.

Please initiate actions necessary to correct the cited violation and submit a signed written response to this Violation Notice by November 2, 2020 (which coincides with 21 calendar days from the date of this letter). The response should include:
 the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
With your response please include the load tickets for demolition debris and concrete as well as waste manifests for the asbestos waste.


If either party believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide factual information to explain your position.
