## SECOND VIOLATION NOTICE

## This letter supersedes the violation notice issued on January 5, 2023, that listed Salem Jiddou as the owner of Lahser Estates LLC.

On October 26, 2022, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of the commercial building located at 21650 West 11 Mile Road, Southfield, MI. The purpose of this inspection was to determine the owner/operators' compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Lasher Estates LLC owns the facility. SJ Design & Construction, LLC and A.L. Saylor Excavating/Demolition, LLC performed the demolition activities at the facility. The NESHAP for Asbestos holds the owner and operators liable for violations.

On November 4, 2022, the AQD sent Lahser Estates LLC, SJ Design and Construction, LLC and A.L. Saylor Excavating/Demolition, LLC a Violation Notice citing violations discovered as a result of the inspection and requested your written response by November 28, 2022. A copy of that letter is enclosed for your reference. As of this date, we have not received a response from Lahser Estates LLC.

Please be advised that failure to respond in writing and identifying actions Lahser Estates LLC, will take or has taken to resolve the cited violations may result in escalated enforcement action by the AQD. Please provide the information requested in our November 4, 2022, letter by March 15, 2023, which corresponds to 14 days from the date of this letter.
