## VIOLATION NOTICE

On June 22, 2023, the Department of Environment, Great Lakes, and Energy (EGLE). Air Quality Division (AQD), conducted an inspection of the vacant school building located at 465 E. Jackson, Lake Orion. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Lake Orion Community Schools (LOCS) owns the facility, Frank Rewold & Sons Inc. (FRS) was overseeing the project, Blue Star, Inc. performed the demolition activities and Detroit Environmental Solutions LLC conducted the asbestos removal activities at the facility. The NESHAP for Asbestos holds both the owner and operators equally liable for violations.

During the inspection, staff observed the following: A subject property undergoing complete demolition. Within the building debris EGLE staff identified regulated asbestos containing material (RACM), rope gasket, that had previously been identified as ACM in Mike Gagnon, Frank Rewold & Sons, Inc. the asbestos survey report. The same material was sampled by EGLE staff at the time of inspection and tested positive for asbestos.

Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by August 1, 2023 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
