Robinson Township Fire Department demolished the structure by means of Intentional Burn. According to my investigation, Mr. Mark Sloothaak owns the subject property and the liable for any violations. The National Emission Standard for Asbestos holds both the owner and operator equally

The subject property had been burned for training purposes by the Robinson Township Fire Department. A 10-day notification had not been submitted.
