**ENFORCEMENT NOTICE**

ATTENTION: Mr. Braddock:

This letter is to advise you of the commencement of escalated enforcement action against Braddock Demolition Cleaning & Hauling, LLC (Company) for alleged violations that occurred at the addresses of 800 and 802 Hoyt Avenue, Saginaw, Michigan (ID: U731805167 & U731805166). This letter follows the August 14, 2018 Violation Notice issued by the Department of Environmental Quality (DEQ), Air Quality Division (AQD) which details violations of the National Emission Standards for Hazardous Air Pollutants for asbestos (Asbestos NESHAP), Code of Federal Regulations, Title 40, Part 61, Subpart M; and Rule 942 of the Michigan Air Pollution Control Rules, Mich Admin Code, R 336.1942.

On November 23, 2015, the DEQ and the Company entered into a Stipulation for Entry of Final Order by Consent AQD No. 34-2015 (Consent Order 34-2015), to resolve past violations of the Asbestos NESHAP. Consent Order 34-2015 required the payment of a settlement amount of \$8,000.00 divided over 6 installments. To date, only 3 payments have been received, leaving an unpaid balance of \$3,900.00. A copy of Consent Order 34-2015 is enclosed for your reference.

Additionally, on July 25, 2016, the DEQ issued a stipulated fine of \$1,000.00 for a violation of the Asbestos NESHAP, which occurred at 1405 North Michigan Avenue, Saginaw, Michigan. A copy of the stipulated fine letter is enclosed for your reference. This balance also remains unpaid.

The AQD is requesting that the Company respond to this Enforcement Notice and schedule a meeting to discuss the resolution of these violations and payment of overdue fines.


