VIOLATION NOTICE

On March 15, 2016, the Department of Environmental Quality (DEQ), Air Quality Division, performed an asbestos NESHAP inspection at 930 Court Street, Port Huron, Saint Clair County, Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to my investigation, Mr. Dave Smith of the City of Port Huron is the owner of the subject property and Mr. James Hollenbeck of Blue Moon Abatement is the contractor who has performed the abatement activities. The abatement activities occurred on or about March 3, 2016. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the investigation, staff observed the following:

Please initiate actions necessary to correct the cited violation and submit a written response to this violation notice by April 11, 2016 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation, and the dates by which these actions will take place; and what steps are being taken to prevent a
