On Tuesday, August 6, 2019, Michigan Department of Environment, Great Lakes, and Energy-Air Quality Division (EGLE-AQD) staff, I, Adam Bognar, conducted a self-initiated inspection of Pride St. Clair located at 50701 Birch Lane, Shelby Township, MI 48315. The purpose of this inspection was to determine the facility's compliance status with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control of Natural Resources and Environmental Protection Act, 1994 Public Act 451, Michigan Department of Environment, Great Lakes, and Energy-Air Quality Division (EGLE-AQD) rules; and Permit to Install No. 539-92.

I arrived at this location at around 11 am.

According to AQD files, Pride St. Clair operated a plastic injection molding process at this location in the past. The last records of communication between AQD and the company was in 1992 when Pride St. Clair obtained Permit to install No. 539-92 for the injection molding process. Permit to Install No. 539-92 is an active permit.

The warehouse at this address is now occupied by Connell Equipment Leasing Company. An employee at the front desk allowed me into the storage warehouse. I identified myself, provided credentials, and stated the purpose of the inspection. I explained that there is an active air permit for a plastic injection molding process associated with the warehouse. The warehouse is full of construction/industrial equipment such as forklifts, endloaders, and cranes. There are 6 employees working here. I was able to verify that the equipment associated with Permit to Install No. 539-92 has been removed from the location.

There does not appear to be any AQD regulated equipment in this warehouse. The warehouse is used for storage of mobile equipment.

The AQD Pride St. Clair file will be archived as a result of this inspection.

Compliance Determination

Connell Equipment Leasing Company appears to be operating in compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control of Natural Resources and Environmental Protection Act, 1994 Public Act 451; and Michigan Department of Environment, Great Lakes, and Energy-Air Quality Division (EGLE-AQD) rules.
