VIOLATION NOTICE

On March 13, 2019, the Department of Environmental Quality (DEQ), Air Quality Division, performed an asbestos NESHAP (National Emission Standard for Hazardous Air Pollutants) complaint investigation at 3144 East M-21, Corunna, Shiawassee County. The purpose of this investigation was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to our investigation, Mr. Michael Malachowski owns the subject facility and Don Henry Construction performed the demolition activities. The National Emission Standard for Asbestos holds both the owner and/or operator equally liable for any violations.

During the inspection, DEQ staff observed the following:

The former GiGi's Banquet and Catering facility had been demolished and new construction was occurring. The owner and/or operator did not have a thorough asbestos inspection performed prior to the demolition activities and no Notification of Intent to Renovate/Demolish had been submitted to the administrator.

On March 12, 2019, staff received a complaint regarding demolition activities that took place at 3144 East M-21, Corunna. Please initiate actions necessary to correct the cited violations and submit a written response to this violation notice by April 5, 2019, (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a

summary of the actions that have been taken and are proposed to be taken to correct the violations, and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If you believe the above observations or statements are inaccurate or do not constitute a violation of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
