VIOLATION NOTICE

On September 14, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of KBR Recycling (Company) located at 9292 Oakville Waltz Road, Willis. The purpose of this inspection was to determine the Company's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451) and the associated Air Pollution Control Rules.

During the inspection, AQD staff observed the following:
