CONSENT JUDGMENT

Plaintiff, Michigan Department of Environment, Great Lakes, and Energy

(EGLE), and Defendant, J Brown Environmental Construction Company, Inc.

(Brown Environmental), hereby stipulate:

A. On December 10, 2021, this Court granted EGLE's Motion for Summary Disposition pursuant to MCR 2.116(C)(10) against Brown Environmental finding Brown Environmental violated Sections 61.145(b)(3)(iv)(A)(1) and (2), 61.145(c)(1) and 61.150(b)(1) and (2) of 40 CFR Part 61, Subpart M, 40 CFR 61.140– 157 (the "Asbestos NESHAP") which has been incorporated by Part 55, Air Pollution Control, of Michigan's Natural Resources and Environmental Protection Act (NREPA), MCL 324.5501 *et seq.* See MCL 324.5512; Mich Admin Code, R 336.1942.

B. Pursuant to this Court's January 12, 2022, Order, an evidentiary hearing was set for April 6, 2022, for purposes of imposing any civil fines and awarding any costs of litigation that this Court determined appropriate for which Brown Environmental is liable to pay EGLE pursuant to Section 5530(2) and (4) of Part 55 of the NREPA, MCL 324.5530(2), (4).

C. EGLE and Brown Environmental agree that resolution of this action through this Consent Judgment, and without further litigation, is in the public interest and the most appropriate means of resolving the issues raised in this action.

Therefore, before the taking of additional testimony, and upon consent of the parties, IT IS HEREBY ORDERED:

Brown Environmental shall pay EGLE \$90,000.00 as a civil fine pursuant to MCL 324.5530(2).
