**SECOND VIOLATION NOTICE**

On September 29, 2016, the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of the former commercial facility located at 16508 Hamilton Avenue, Highland Park, MI. The purpose of this inspection was to determine Simply Construction & Excavating, LLC's and Faith Tabernacle Church's compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On October 21, 2016, the AQD sent the company a Violation Notice citing violation(s) discovered as a result of the inspection and requested your written response by November 11, 2016. A copy of that letter is enclosed for your reference. As of this date, we have not received your response.


Please be advised that failure to respond in writing and identifying actions the owner will take or has taken to resolve the cited violation may result in escalated enforcement action by the AQD. Please provide the information requested in our October 21, 2016 letter by December 7, 2016, which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.
