## VIOLATION NOTICE

On November 15, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of the former Harvest International Worship Center located at 24921 Ford Road, Dearborn. The purpose of this inspection was to determine AK Construction Company Inc.'s and West Ford Road Investments LLC's compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, West Ford Road Investments, LLC owns the facility and AK Construction Company performed the demolition activities at the facility. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, DEQ AQD staff Tammy S. Bell noted that a 10 day notification of intent to renovate/demolish had not been submitted for the demolish of the former church.

The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence. Both parties are required to respond to this violation notice.

If AK Construction Company, Inc. and/or West Ford Road Investments, LLC believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
