## VIOLATION NOTICE

On March 22, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of the commercial building located at 22750 Allen Road, Woodhaven. The purpose of this inspection was to determine Faction Development, LLC's and NCS Construction Services, LLC's compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Faction Development, LLC owns the facility and NCS Construction Services, LLC performed the renovation activities at the facility. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff observed that over 160 square feet of building materials had been removed from the commercial building during building renovation. DEQ staff contacted NCS Construction Services, LLC to request a copy of the asbestos survey, but no information was provided to the DEQ.

The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Faction Development, LLC and/or NCS Construction Services, LLC believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to me during my inspection of 22750 Allen Road, Woodhaven.
