VIOLATION NOTICE

On May 24, 2017, the Michigan Department of Environmental Quality (MDEQ), Air Quality Division (AQD), performed asbestos inspections at 1072 Manistique Street and 233 Ashland Street, Detroit, Wayne County, Michigan. The purpose of these inspections was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to our investigation, the Detroit Land Bank owns these residential properties. These sites were under a contract for demolition through the City of Detroit and the Detroit Building Authority, which oversees demolitions for the City. MWV Environmental Services notified and conducted asbestos abatement at the sites. The National Emission Standard for Asbestos holds the <u>owner</u> and <u>operators</u> equally liable for all violations.

During the investigation, DEQ AQD staff, Mr. Jeremiah Brown observed/discovered the following:

The subject properties had been abated and Regulated Asbestos-Containing Material (RACM) was left behind and had not been removed.

The written response should include: the date(s) the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations, and the date(s) by which these actions will take place; and what steps are being taken to prevent a reoccurrence. The <u>signed</u> written response from both the <u>owners and operators</u> to this violation notice may be submitted by mail and directed to my attention at; DEQ AQD, P.O. Box 30260, Lansing, Michigan 48909, or scanned and sent as an email attachment to brownj9@michigan.gov.

If you believe the above observations or statements are inaccurate or do not constitute a violation of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
