VIOLATION NOTICE

On June 4, 2018, the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of a site located at 6642 Michigan Avenue, Detroit. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Jonathon & Justin, Inc. owns the facility and Berkshire Development, Inc. performed the demolition activities at the facility. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

During the investigation, staff discovered the following:

A Notification of Intent to Demolish was not submitted to the MDEQ the required 10 working days in advance of the start of the demolition.
