VIOLATION NOTICE

On August 17, 2018, the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of the residential property located at 6221 Inkster Road, Taylor. The purpose of this inspection was to determine Wayne County's, the City of Taylor's and Smalley Construction, Inc's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Wayne County owns the facility and Smalley Construction, Inc. performed demolition activities on behalf of the City of Taylor. The NESHAP for Asbestos holds the owner and operators liable for violations.

DEQ AQD staff conducted an inspection of the site and noted small pieces of painted cementitious asbestos siding around the property and in the soil post-demolition. A sample collected at the site found that the siding tested positive for asbestos.

Please initiate actions necessary to correct the cited violation and submit a signed written response to this Violation Notice by October 1, 2018 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
