VIOLATION NOTICE

On July 18, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of the former Oakwood Food Center located at 3600 Oakwood, Melvindale. The purpose of this inspection was to determine the owner's and operators' compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Melvindale Investments, LLC owns the facility and A.L. Saylor Excavating/Demolition, LLC and SJ Design & Construction, LLC performed the demolition activities at the facility. The NESHAP for Asbestos holds the owner and operators liable for violations.

During the inspection, EGLE staff observed the building had been demolished without the submittal of the required 10-day notice of intent to demolish. Samples were collected and Category I and II materials were found post demolition at the site. A copy of the asbestos survey was requested but was not provided.

Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by August 27, 2019 (which coincides with 21 calendar days from the date of this letter). The response should include:

- a copy of the asbestos survey conducted prior to demolition;
- the dates the violations occurred;
- an explanation of the causes and duration of the violations;
- whether the violations are ongoing;
- a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and
- and what steps are being taken to prevent a reoccurrence.

If A.L. Saylor Excavation /Demolition, LLC, SJ Design & Construction, LLC and Melvindale Investments, LLC believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide factual information to explain your position.
