## **VIOLATION NOTICE**

On October 5, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of the residential property located at 3536 Byrd, Dearborn. The purpose of this inspection was to determine Progressive Real Estate's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Progressive Real Estate owns the facility and unknown contractor(s) performed the demolition and renovation activities at the facility. The NESHAP for Asbestos holds both the owner and operators liable for violations.

During the inspection, AQD staff observed the garage had been demolished, and the house has been renovated. A thorough inspection for asbestos had not been conducted prior to renovation/demolition activities. Asbestos containing materials were found disturbed at the site.

Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by November 30, 2018 (which coincides with 21 calendar days from the date of this letter). The response should include: name and contact information for contractor(s) that performed work at the site; the dates the violations occurred; an explanation of the causes and duration of the violations; whether

the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
