SECOND VIOLATION NOTICE

On March 6, 2019, the Michigan Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) performed an asbestos inspection at 6216 Iroquois Avenue, Detroit, Michigan; 6415 Iroquois Avenue, Detroit, Michigan; 6432 Iroquois Avenue, Detroit, Michigan; and 6433 Iroquois Avenue, Detroit, Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On March 27, 2019, the AQD sent a Violation Notice (VN) citing a violation discovered because of the inspection and requested a written response by April 17, 2019. A copy of this VN has been enclosed for your reference. As of the date of this letter, the AQD has not received the written response to the cited violation.

Please be advised that failure to respond in writing and identifying actions taken to resolve the cited violation may result in an escalated enforcement action by the AQD. Please provide the information requested in the VN dated March 27, 2019, by May 9, 2019, which corresponds to 14 days from the date of this letter.

The written response must be submitted to Mr. Jeremiah Brown, EGLE, AQD, P.O. Box 30260, Lansing, Michigan 48909-7760, and must include a copy to Mr. Jason Wolf, Enforcement Unit, AQD, at the same address. Or the response may be scanned and sent to brownj9@michigan.gov and wolfj2@michigan.gov.

Be further advised that issuance of this VN does not preclude or limit EGLE's ability to initiate any other enforcement action under state or federal law as appropriate.


